

# **Evidence Vault**

Secure cloud-based evidence sharing



Looking for an easy way to safely share cases outside of your network without the hassle of portable media or the vulnerabilities associated with email and file sharing options? **Evidence Vault** from March Networks lets you export cases to the cloud, then share them with authorized recipients. When you export a case to Evidence Vault, the designated recipient(s) will be notified by email, allowing them to access that case in the cloud and download it.

Additionally, Evidence Vault allows System Administrators to monitor and control access to cases via user permissions and activity audits.

This subscription-based solution is offered in a variety of packages, based on your storage requirements, and the term of your subscription.

This service, which is provided out of the US and supported through Canada, is for existing March Networks customers using March Networks recorders and Command Enterprise Software.

## **Key Benefits**


- Direct export. Export case evidence directly from a March Networks recorder or Media Archiver to the cloud using Command Client; no need to download evidence to a local PC first.
- ▼ **Upload to Evidence Vault.** The easy-to-use web client interface lets you upload evidence in any file format. Uploads are initially private until shared, and external agents can be given upload rights.
- Send Email notification. Select the file(s) to share, then enter the recipients' email addresses.
- Download evidence. Recipients can log into the web client to view and download shared files.
- ▼ **Keep evidence secure.** Multiple measures are in place to ensure your case evidence is protected, including an expiry on sharing time, encryption in transit and at rest, and an activity log to facilitate auditing.
- Accommodates any file format. Evidence Vault can accommodate your file type of preference, including March Networks' proprietary .cme file format, jpeg, pdf, etc.
- ▼ Chain of custody. All actions are logged within the system's activity audits, which track who has viewed, shared, or downloaded evidence.
- Compatible with your device of preference. The Evidence Vault web client runs on any device, including laptops, PCs and tablets, and because it is updated via marchnetworks.cloud, no updates are required.
- ▼ Tag files for easy retrieval. Improve the search speed by tagging files with relevant keywords, then use those tags to do a quick search.

Safely and efficiently store and share evidence in the cloud; monitor and control access to that evidence.
